A PURSUIT OF KNOWLEDGE AND A COMMITMENT TO ACHIEVEMENT OF POTENTIAL</b></p> <p><i>The lifelong disposition toward the quest for knowledge, as each person strives to understand the social and natural worlds and how best to make a contribution to these worlds. Each person is encouraged to achieve his or her potential in all respects and, through critical and creative thinking, to develop a broad understanding of his or her own values and world views.</i></p>	<p><b>2. SELF ACCEPTANCE AND RESPECT OF SELF</b></p> <p><i>The acceptance and respect of self, resulting in attitudes and actions that develop each person's unique potential — physical, emotional, aesthetic, spiritual, intellectual, moral and social. Encouragement is given to developing initiative, responsibility, ethical discernment, openness to learning and a sense of personal meaning and identity.</i></p>	<p><b>3. RESPECT AND CONCERN FOR OTHERS AND THEIR RIGHTS</b></p> <p><i>Sensitivity to and concern for the well-being of other people; and respect for life and property.
